## LEGAL STUDIES MAJOR REQUIREMENTS

Legal Studies majors must complete a minimum of 37-47 credits including the Junior Year Writing and Integrative Experience courses and a Global Law & Society requirement. All coursework for the major must be taken for a letter grade and carry at least 3 credits, and no more than 2 transfer courses (or a maximum of 8 transfer credits) may count toward the major. Students must maintain a minimum 2.0 GPA within the major as well as overall, at the University, to graduate.
